### **INVITATION FOR BIDS**

## I. BIDS:

Sealed bids will be received by the County of Boone - Missouri for the **Sale of Computers, Peripherals and other Hardware** located in Boone County Government Center, Purchasing Department, 801 E. Walnut Street, Columbia, Missouri. Bidders shall hold their bids firm for a period of three (3) months from date of award.

# II. DESCRIPTION:

The Boone County Information Technology department desires to sell surplus consisting of items such as Central Processing Units (CPU's), Computer Monitors, Modems, and Printers. All items are used and are sold "as is", with no warranties.

## III. BID FORM:

Attached hereto is an Invitation for Bid Form to be used for the submission of information requested herein. The Purchasing Department of Boone County must receive the Bid Form no later than July 1, 2003 at 1:25 P.M., C.S.T. The bid must be sealed and clearly addressed to the Office of the Director, Boone County Purchasing, 601 E. Walnut, Room 208, Columbia, MO 65201 with a notation of the sealed envelope marked "Bid for Sale of Computers, Peripherals and Hardware (IFB # 05-01JUL03)".

## IV. <u>WITHDRAWAL OF BIDS:</u>

Any bidder may withdraw their bid at anytime prior to the scheduled closing time for the receipt of bids, but no bidder may withdraw their bid for a period of sixty (60) days after the scheduled closing time for the receipt of bids. Only telegrams, letters and other written requests for corrections of a previously submitted bid which are addressed in the same manner as bids and are received by the County prior to the scheduled closing time for the receipt of bids will be accepted.

## V. AWARD:

The Invitation for Bid form allows bidders to provide one bid for all the Computers, Peripherals and Hardware surplus equipment, or provide a bid for Lot A, and/or Lot B and/or Lot C.

The County shall make award to the highest and best bidder(s). Boone County reserves the right to award this bid to one bidder or multiple bidders, at Boone County's sole discretion. The County reserves the right to reject any and all bids and to waive informalities in bids.

## VI. TERMS OF SALE:

- A. The material for sale is offered for sale on an "as is" and "where is" basis, and the County makes no guarantee as to its condition.
- B. At the option of the County, the Purchase Price shall be paid by a Certified or Cashiers Check, payable without condition to the "County of Boone Missouri" in advance of the removal of the property. If payment is not made within the specified time, the property shall then become the property of the County and the bid will be considered void.
- C. Inspection of Equipment/On-Site Pre-Bid: It is understood by bidder in submitting a bid that the bidder is responsible for viewing the material for sale and discovering the procedures required for the removal of such. If prospective bidders desire to inspect the Computers, Peripherals and Hardware surplus property prior to submitting a bid, they should attend the on-site pre-bid being held on Thursday, June 19, 2003, at 9:00 a.m., in Conference Room 220 of the Boone County Government Center, 801 E. Walnut Street, Columbia, Missouri. The equipment will be available for viewing immediately following the pre-bid. This is the only date and time the listed equipment will be available for inspection. Please note the equipment will be available for viewing only, none of the equipment will be powered-up.
- D. **Invitation for Bid Deposit:** A deposit equal to 10% of the total amount must accompany each Invitation for Bid offered. The County will have the right to retain as its own, such deposit, should award be made and bidder fails or refuses to complete the purchase per the specification. All such deposits except that of the bidder whose bid shall have been accepted by the County will be returned to the person or persons making the same within ten (10) days after award. The successful bidder's deposit will be applied to the total amount due.
- E. **Payment after Notice of Award:** The successful bidder(s) will have fourteen calendar days, after receipt of notification of award, to pay Boone County the balance due and remove ALL the equipment. Payment shall be submitted to Boone County Missouri, C/O Melinda Bobbitt, Director of Purchasing, along with a copy of the letter of award. Check shall be made payable to "County of Boone Missouri".
- F. **Personal Examination:** Bidders are required to satisfy themselves, as to work involved and of the condition of the equipment to be sold. No plea of ignorance of conditions that exist, or that may hereafter exist, or of the condition of the equipment, or of the work included under this contract will be accepted as an excuse for any failure to or omission on the part of the contractor to fulfill in every respect all the requirements of these specifications, nor will same be accepted as a basis for any claim for relief from compensation.
- G. **Warranties:** The County makes no representation or warranty, including without limitation hereby any representation or warranty regarding merchantability or fitness for a particular purpose, regarding the equipment, or any part thereof, or in

the use, functions, operation or performance thereof.

- H. ALL COMPUTERS, PERIPHERALS AND HARDWARE EQUIPMENT WILL BE SOLD WHERE IS AND AS IS.
- I. INDEMNITY AGREEMENT To the fullest extent permitted by law, Contractor shall indemnify, hold harmless and defend the County, its directors, agents, and employees from and against all claims arising by reason of any act or failure to act, negligent or otherwise, of Contractor, (meaning anyone, including but not limited to consultants having a contract with Contractor or subcontractor for part of the services), of anyone directly or indirectly employed by Contractor, or of anyone for whose acts the Contractor may be liable, in connection with providing these services. This provision does not, however, require Contractor to indemnify, hold harmless, or defend the County of Boone from its own negligence.

### VII. BASE BID

- A. **Scope:** Various Boone County departments have supplied the Computers, Peripherals and Hardware surplus property offered in this Invitation for Bid. Attachment A consists of lists of the Computers, Peripherals and Hardware surplus equipment for sale under this Invitation for Bid. Attachment A indicates any information Boone County has available for the listed items, such as models, part numbers, serial numbers, and county tag numbers. Please note that Boone County has made its best effort to provide correct information in this respect, however the County will not be held accountable for any typographical errors with respect to those items.
- B. **Removal:** The Computers, Peripherals and Hardware surplus equipment is offered for sale F.O.B. Point of Origin with all transportation charges and the risk of loss or damage the responsibility of the Contractor.

Computers, Peripherals and Hardware equipment shall be available immediately upon contract award. The successful bidder shall be responsible for packing, preparation, loading and removing the material for sale from County property, including all related costs. Boone County will not assist in the handling or transportation. All equipment awarded to Contractor must be removed from Boone County property.

Removal must be scheduled a minimum of three (3) days in advance. Removal operations shall occur during normal working hours only, 8:00 a.m. to 4:00 p.m., on workdays, Monday through Friday, and shall not interfere with the operations of the Purchasing Department or any other County entity.
