ADDENDUM #2
(Issued August 2, 2004)

This addendum is issued in accordance with the Introduction and General Conditions of Bidding and is hereby incorporated into and made a part of the Contract Documents. Bidders are reminded that receipt of this addendum should be acknowledged and submitted with bidder's *Response Form*.

Specifications for the above noted Request for Bid and the work covered thereby are herein modified as follows, and except as set forth herein, otherwise remain unchanged and in full force and effect:

BID DOCUMENTS:

The Form of Non-Collusive Affidavit is attached to this addendum.

Prevailing Wage Order No. 11 is attached to this addendum. However, due to excessive size requirements, if you downloaded the addendum from the Internet, you must download Prevailing Wage Order No. 11 separately. It is located on the Purchasing page at www.showmeboone.com under the heading "Current Prevailing Wage".

Revise Section A 1. m. on Page 19, in its entirety, as follows:

Colors: All items shall be painted Sherwin Williams #SW-4007 Lodestone color except H.M. doors and frames shall be painted Sherwin Williams #SW-4006 Bronze. The East entrance soffit, fascias, canopy ceiling, and trim around the East windows shall all be painted white (Sherwin Williams Pure White LRV 85%). Trim around all other windows shall be painted the same color as the rest of the building (SW-4007 Lodestone).

Add section A 1. n. on Page 19 as follows:

Pressure wash, prep, prime, and paint the 10'X10' white wall area on the East side of the building the same color as the rest of the building (SW-4007 Lodestone).

Revise Part 2 Products, Section 2.3 B. 1. on Page 29, in its entirety, as follows:

Primer shall be Sherwin-Williams SW ProCryl Universal Primer, B66-310 Series, 2-4 mils dry, or approved equal.


Revise Part 3 Execution, Section 2.1.C., on Page 30, in its entirety, as follows:

Apply coatings using methods recommended by manufacturer. Clean and pressure wash the existing surface of all foreign material. If existing paint is peeling or badly weathered, clean surface to sound substrate and treat as a new surface. After cleaning, let existing surface dry, apply primer on a minimum of three test areas and allow primer to dry one week before testing adhesion. If adhesion is poor, or if this product attacks the previous finish, contact the Owner's Representative.

Revise Part 3 Execution, Section 2.1.D., on Page 30, in its entirety, as follows:

Uniformly apply coatings without runs, drips, or sags, without brush marks, and with consistent sheen. Contractor shall spray paint all surfaces except for window frames, trim, and miscellaneous items requiring brushwork.
