BID DOCUMENTS:

The title of bid 14-25FEB05 has been changed from Model Year 2005 Cargo Van to Model Year 2005 15 Passenger Van.

Section 2.1. has been revised as follows:

ITEMS TO BE PROVIDED – Boone County, hereafter referred to as “County”, proposes to contract with an individual(s) or organization(s), hereinafter referred to as “Contractor” for a contract for the furnishing of a new 2005 Model Year 15 Passenger Van as detailed in the following specifications. Acceptable models shall include the following: GMC Savana, Ford Econoline, Chevrolet Express, or equivalent. **Vehicle is to be issued with a “cargo” style area behind driver and front passenger seats with no additional seating or carpet.**

Section 2.2.15. has been revised as follows:


