Boone County, Missouri is accepting sealed bids for 53-18AUG05 Sheriff's Department North Substation Site Work

Project Construction: *Grading of project site to prepare surface and subgrade for construction of a driveway and parking area consisting of approximately 890 SY of an 8" thickness of compacted aggregate base and 808 SY of Chip & Seal surfacing (two applications).*

Sealed bids, subject to the Instructions and General Conditions of Bidding, will be accepted until 1:15 P.M. on August 18, 2005, at the Boone County Purchasing Office, 601 E. Walnut, Room 209, Columbia, Missouri, 65201. Bids received after the above specified time for acceptance will be returned to the sender unopened.

The bid is scheduled to be publicly opened after 1:30 P.M. on August 18, 2005 in the Boone County Commission Chambers, Boone County Government Center, 801 E. Walnut, Columbia, MO 65201.

The County reserves the right to select and award the bid item or items which best suit its needs, whether the price is the lowest or not, and also reserves the right to reject any and all bids or waive informalities or irregularities.

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract. The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.
