1. INTRUCTIONS AND GENERAL CONDITIONS

- 1.1 **Delivery of Proposals:** Sealed proposals, subject to Instructions and General Conditions and any special conditions set forth herein, will be received at the Boone County Purchasing office until the proposal closing date and time indicated herein for furnishing the County with services as detailed in the following request for proposal.
 - a) **Proposal Closing:** All proposals shall be **delivered before 10:30 A.M.,** C.S.T., on **Tuesday, February 28, 2006** to:

- b) The County will not accept any proposals received after 10:30 A.M. and will return such late proposals to the Offeror.
- c) Offerors must submit one (1) original, and six (6) copies of the proposal (total of seven). Proposals will be opened publicly but only names of Offerors will be read aloud.
- d) Proposals must be submitted in a sealed envelope identified with the proposal number and date of closing. List the proposal number on the outside of the box or envelope and note "Response to Request for Proposal enclosed."
- e) If you do not care to submit a proposal, please return the *No Bid Response Form* and note your reason. No fax or electronic transmitted proposals will be accepted, however, the *No Bid Response Form* may be returned by fax.
- f) If you have obtained this proposal document from our Web Page or from a source other than the Boone County Purchasing Department, please check with our office prior to submitting your proposal to ensure that you have a complete package. The Purchasing Department cannot be responsible for providing addenda if we do not have you on our Vendor list for this proposal.

1.2. Evaluation of Proposals (Procedure):

a) The County will first examine proposals to eliminate those that are clearly non-responsive to the stated requirements. Therefore, Offerors should exercise particular care in reviewing the Proposal format required for this RFP.

- b) The evaluation committee shall then score all proposals based upon the evaluation factors detailed herein. Upon completion of the scoring, the committee may recommend short listing the proposals that are potentially acceptable.
- c) At this point, the County may request presentations by Offerors, and carry out negotiations for the purpose of obtaining best and final offers, and conduct detailed reference checks on the short listed Offerors.
- d) The County reserves the right to contact any and all references to obtain, without limitation, information regarding the Offeror's performance on previous projects. A uniform sample of references may be checked for each short-listed Offeror.
- e) The County reserves the right to withdraw this RFP at any time and for any reason and to issue such clarifications, modifications, and/or amendments as it may deem appropriate.
- f) Receipt of a proposal by the County or a submission of a proposal to the County offers no rights upon the Offeror nor obligates the County in any manner.
- g) No negotiations, decisions, or actions shall be initiated by any firm as a result of any verbal discussion with any County employee prior to the opening of responses to the Request for Proposal. Boone County reserves the right to select the Offeror which best meets its goals and objectives, needs, fiscal constraints, quality levels and service expectations.

1.3 Ambiguity, Conflict, or Other Errors in the RFP:

- a) If an Offeror discovers any ambiguity, conflict, discrepancy, omission, or other error in the Request for Proposal, they shall immediately notify the Department of such error in writing and request modification or clarification of the document. The County will make modifications by issuing a written revision and will give written notice to all parties who have received this RFP from the County.
- b) The Offeror is responsible for clarifying any ambiguity, conflict, discrepancy, omission, or other error in the Request for Proposals prior to submitting the proposal or it shall be waived.
- c) Implied Requirements: Products and services that are not specifically requested in this RFP, but which are necessary to provide the functional capabilities proposed by the Offeror, shall be included in the proposal.
- d) The County will not be liable in any way for any costs incurred by any Offeror in the preparation of their proposal in response to this RFP, nor for the presentation of their proposal and/or participation in any discussions or negotiations.

- 1.4 Rejection of Proposals: The right is reserved to accept or reject in whole or in part any or all proposals submitted, to waive technicalities, and to accept the offer the County considers the most advantageous to the County. Further, the County shall reject the proposal of any Offeror that is determined to be non-responsive. The unreasonable failure of an Offeror to promptly supply information in connection with respect to responsibility may be grounds for a determination of non-responsibility.
- 1.5 **Acceptance of Proposals:** The County will accept all proposals that are submitted properly. However, the County reserves the right to request clarifications or corrections to proposals.
- 1.6 **Requests for Clarification of Proposals:** Requests by the Purchasing Department for clarification of proposals shall be in writing.
- 1.7 **Validity of Proposals:** Offeror should state how many days or months proposals remain valid beyond the 120 days minimum.
- 1.8 **Receipt and Opening of Advertised, Sealed Proposals:** The Offeror(s) and public are invited, but not required, to attend the formal opening of proposals. Offeror(s) names only will be read aloud to the public. No decisions related to an award of a contract or creation of any contractual or lease relationship, or purchase order will be made at the opening.
 - a. Information provided in your response will be considered proprietary and will not be divulged during the selection process. The successful firm's proposal will become public record after its acceptance by the County Commission. All proposals and tabulation sheets are kept by the County for a period of time established by regulation or statutes after the award is made and are available for inspection at any time during regular working hours.
 - b. Proposals will be opened and Offeror's names read aloud during the proposal opening in the Boone County Johnson Building, Conference Room 213, Tuesday, February 28, 2006 at 10:30 A.M., C.S.T. located at the following address:

1.9 **Withdrawal of Proposals:** Proposals may be withdrawn without prejudice any time before the deadline for receipt of proposals. If a mistake or error is discovered by the Offeror or by the County after the proposal opening, the County has the right to call this error to the Offeror's attention and request verifications of the proposal. If the Offeror acknowledges the mistake and requests relief, the County will proceed in the following manner:

a. **Withdrawal:** Permission to allow an Offeror to withdraw their proposal without prejudice may be given when clear and convincing evidence supports the existence of an error. If there is a significant and obvious disparity between the prices of the lowest Offeror and of the other Offerors, an Offeror may be permitted to withdraw without prejudice, upon submission of evidence that a non-intentional error occurred.

2.3. Pre-Proposal Conference

- 2.3.1. To assist interested Offerors in preparing a thorough proposal, a pre-proposal conference has been scheduled for **February 7, 2006, at 10:30 a.m.** in the Boone County Johnson Building, Conference Room 213, 601 E. Walnut, Columbia, Missouri 65201.
- 2.3.2. All potential Offerors are encouraged to attend this conference in order to ask questions and provide comment on the Request for Proposal. Attendance is not mandatory to submit a response; however, Offerors are encouraged to attend since information relating to this RFP will be discussed in detail. Offerors should bring a copy of the RFP since it will be used as the agenda for the pre-proposal conference.
- 2.3.3. Offerors are strongly encouraged to advise the Purchasing Department of Boone County within five (5) days of the scheduled pre-proposal conference of any special accommodations needed for disabled personnel who will be attending the conference so that these accommodations can be made.



3.0 SCOPE OF SERVICES

3.1. Project Description:

The County of Boone – Missouri, hereafter referred to as *the County*, hereby solicits formal written proposals from qualified restaurants to provide **meal service** for the County. There are two needs addressed in this proposal. **Option One** is for **Delivered Meals** to various Boone County locations within eight miles of Columbia, Missouri. **Option Two** is for **Dining-In Restaurant Meals**. Both options shall include selections from a menu created for Boone County for employees and others that will need meals delivered or will be dining-in various restaurants within walking distance of the Boone County Courthouse, located in downtown Columbia, Missouri. Offeror's may bid on Option One or Option Two or both Option One and Option Two.

3.2.Background:

- 3.2.1. Boone County Government currently has staff, jurors, witnesses, victims and others that eat a meal at a restaurant within walking distance of the Boone County Courthouse or by having the meal delivered to a County location. The County desires to contract with restaurants to provide Option One Delivered Meals and/or Option B Dining-In Restaurant Meals. With either option, a menu shall be created for Boone County reflecting Boone County pricing for items (main course, beverage, dessert) that have options sorted by price range. Our objectives are to provide a variety of meal options for our staff while controlling our expenses for said meals, and charging should be easy for our staff with the restaurant mailing the bills to the respective departments.
- 3.2.2. Following are examples of when meals are provided for Boone County staff and others:

3.2.2.a. Delivered Meals:

- Prosecuting Attorney's office feeds witnesses waiting in their office (trial, depositions, interviews) that are unable to leave the premises and need a meal delivered.
- Sheriff Department activates the Mid-Missouri Case Squad and there are law enforcement personnel from multiple agencies that are headquartered at the Boone County Sheriff Department and need a meal delivered.
- Sheriff Department personnel attending inmates that are unable to leave the court house and need a meal delivered.
- Court Administration feeds jurors that are unable to leave the courthouse and need a meal delivered.
- Sheriff Department law enforcement personnel that have to be at a designated area all day without leaving (court house, hospital) and need a meal delivered.

3.2.2.b. Restaurants Located Within Walking Distance of the Courthouse

- Court Administration allows potential Jurors to leave the courthouse to eat at a restaurant within walking distance.
- Prosecuting Attorney's office allows victims/witnesses to leave the courthouse to eat at a restaurant within walking distance.

- 3.2.4. Although an attempt has been made to provide accurate and up-to-date information, the County of Boone Missouri does not warrant or represent that the background information provided herein reflects all relationships or existing conditions related to this Request for Proposal.

3.3 Scope of Services:

The County desires to contract with multiple restaurants that are willing to create a menu for Boone County (for delivered meals and/or dine-in restaurant meals), sorted by selections by price; the County pricing should be based on the restaurant's regular menu less a percent discount.

No guarantee of meals purchased is implied or expressed by this Request for Proposal; meals shall be determined by actual need.

Described below is a general outline of the type of service and product to be delivered by the successful Contractor under the direction of the County designee, and the minimally acceptable standards of performance. This outline is intended as a guide for Offeror(s) to describe the nature of the services required and qualifications for the contract.

Offerors may bid delivered meals only, dining-in restaurant meals only, or both.

3.3.1. General Specifications:

- **3.3.1.1.**The Contractor shall offer decentralized billing by department. Billing shall include contract number, employee name, employee department, meal description with prices based upon menu specified in bid response, date of meal, and case reference.
- **3.3.1.2.Option One Delivered Meals:** Contractor shall provide a menu for Boone County with only certain items that can be delivered to a specific location for the delivered meals. Items should be grouped by similar price range. A minimum of five options under each pricing category should be listed.
 - **3.3.1.2.1.** Prices quoted shall include delivery costs and charges.

- **3.3.1.2.2.** List specifications for packaging materials and types of containers for transporting hot and cold foods that would be used to fulfill the terms of this contract.
- **3.3.1.2.3.** Condiments shall be included with meal price. Please describe if condiments are automatically included with delivered meal or if they will be listed on menu and must be ordered (i.e. salt & pepper packets, sugar, artificial sweetener, mustard, ketchup, mayonnaise,
- **3.3.1.3.**Describe how requests for delivered meals should be ordered: fax, e-mail, phone requests.
- **3.3.1.4.Option Two Dining-In Restaurant Meals:** Contractor shall provide a menu for Boone County with only certain items that can be selected that are grouped by similar price range for eating in the restaurant. A minimum of five options under each pricing category should be listed.
- **3.3.1.5.**The Contractor shall provide a percent off restaurant menu list price for any other items (besides those on the Boone County created menu) selected from restaurant menu.
- **3.3.1.6.**The menu(s) created for Boone County shall not exceed the per diem rate allowed for County staff of \$11.00 for lunch and \$18.00 for dinner. These per diem rates will remain in effect through December 31, 2006. Boone County will provide the new per diem rates at time of contract renewal which will remain firm for the new contract period.
- **3.3.1.7.** The Offeror shall create and submit sample menus with pricing for Boone County for Delivered Meals and/or Dine-In Restaurant Meals which includes food items and beverages. A minimum of five options under each pricing category should be listed. State clearly on menu the time period for the lunch menu and the dinner menu. (These menus will be used for evaluation purpose).

Note: Finalized menus will be prepared by Contractor in consultation and coordination with County representative after contract award.

In addition to the Boone County sample menus, the Offeror shall submit the current restaurant menu being used by Offeror.

- **3.3.1.8.**The restaurant establishment shall meet all state and local foodservice codes.
- **3.3.1.9.**Credit the County when:
 - **3.3.1.9.1.** Food item is missing.
 - **3.3.1.9.2.** Inedible because of poor quality. Poor quality is defined as: burned or discolored; excess visible fat layers and/or overcooked or undercooked foods.

- **3.3.1.9.3.** Out of compliance with the food safety code due to temperature, presence of foreign matter or other potentially hazardous conditions.
- **3.3.1.9.4.** Unable to be eaten because the Contractor has failed to supply utensils, plates or bowls.
- **3.3.1.10.** Submit the name and resume of the manager assigned to supervise this contract.

3.3.1.11. Sanitation:

- **3.3.1.11.1.** List standards, procedures and frequency schedules used in maintaining food preparation facilities.
- **3.3.1.11.2.** Submit inspection reports, from the approval authority of local government, for the food service facility(ies) for the past two years.
- **3.3.1.12.** Potential delivery locations for meals may include, but are not limited to the following:
 - 3.3.1.12.1. Boone County Courthouse, 705 E. Walnut, Columbia, MO
 - 3.3.1.12.2. Boone County Government Center, 801 E. Walnut, Columbia, MO
 - **3.3.1.12.3.** Boone County Sheriff Department, 2121 County Drive, Columbia, MO
 - **3.3.1.12.4.** University of MO Hospital & Clinics, One Hospital Drive, Columbia, MO
 - 3.3.1.12.5. Boone Hospital Center, 1600 E. Broadway, Columbia, MO
 - 3.3.1.12.6. Columbia Regional Hospital, 404 Keene, Columbia, MO
 - **3.3.1.12.7.** Juvenile Justice Center, 5665 N. Roger Wilson Drive, Columbia, MO
- **3.3.1.13.** Proposals should also include the following information:
 - **3.3.1.13.1.** A brief description of the restaurant establishment including location and number of years in operation.
 - **3.3.1.13.2.** The qualifications and background of the restaurant establishment.
 - **3.3.1.13.3.** A list of similar work performed for other counties or agencies, including a description of work and the name of the county or agency. A list of references should be included. Attachment B may be used for this purpose.

3.4. CONTRACTOR Requirements:

3.4.1. Insurance: The Contractor shall purchase and maintain in force, at his/her own expense, such insurance as will protect him/her and the County from claims which may arise out of or result from the Contractor's execution of the work, whether such execution be by himself/herself, his/her employees, agents, subcontractors, or by anyone for whose acts any of them may be liable. The insurance coverage shall be such as to fully protect the contractor and County, from any and all claims for injury and damage resulting by any actions on the part of the Contractor or his/her forces as enumerated above. The Contractor shall furnish a copy of any original Certificate of Insurance, naming Boone County as an additional insured. Should any of the policies be canceled before the expiration date, the issuing company will mail 30 days

written notice to the certificate holder. The Contractor shall furnish insurance in satisfactory limits, and on forms and of companies which are acceptable to the County and shall require and show evidence of insurance coverages on behalf of any subcontractors (if applicable), before entering into any contract agreement to sublet any part of the work to be done under this contract.

- **3.4.2. Indemnity Agreement:** To the fullest extent permitted by law, Contractor shall indemnify, hold harmless and defend the County, its directors, agents, and employees from and against all claims arising by reason of any act or failure to act, negligent or otherwise, of Contractor, (meaning anyone, including but not limited to consultants having a contract with Contractor or subcontractor for part of the services), of anyone directly or indirectly employed by Contractor, or of anyone for whose acts the Contractor may be liable, in connection with providing these services. This provision does not, however, require Contractor to indemnify, hold harmless, or defend the County of Boone from its own negligence.
- **3.4.3.** In performing all services under the resulting contract agreement, the Contractor will comply with all local, state and federal laws.

3.5. Term; Termination of Contract Agreement:

- **3.5.1.** The initial term of the resulting contract agreement from this Request for Proposal for the Meal Service for Boone County will begin April 1, 2006 and extend through December 31, 2006. The agreement may be automatically renewed for an additional four (4) years unless canceled by the Purchasing Director in writing prior to a renewal term. After the fifth term, this Agreement will continue on a month-to-month basis until either party terminates this Agreement by providing the other party with 30 days prior written notice.
- **3.5.2.** The resulting contract agreement may be terminated by the County upon 15 days prior written notice should the other party fail substantially to perform in accordance with its terms through no fault of the party initiating the termination. In addition, the contract agreement may be terminated at will by the County upon at least 15 days prior written notice to the Contractor.

3.6. Additional Information

3.6.1. The County reserves the right to award to one or multiple respondents. In addition, the resulting contract from this RFP will be considered "non-exclusive". The County reserves the right to purchase meal service from other suppliers.



4. PROPOSAL SUBMISSION INFORMATION

4.1. RESPONSE TO PROPOSAL

4.1.1. Submission of Proposals:

- 4.1.1.1. When submitting a proposal, the Offeror should include the **original** and six (6) additional copies.
 - a. The Offeror shall submit the proposal to:

- b. The proposal response must be delivered no later than 10:30 a.m. on February 28, 2006. Proposals will not be accepted after this date and time.
- 4.1.1.2. To facilitate the evaluation process, the Offeror is encouraged to organize their proposal into distinctive sections that correspond with the individual evaluation categories described herein.
 - a. Each distinctive section should be titled with each individual evaluation category and all material related to that category should be included therein.
 - b. The signed response page from the original RFP and all signed amendments should be placed at the beginning of the proposal.
 - c. The Proposal must, at a minimum, address all mandatory and desired services, equipment, materials, etc. Responses will fully describe how the service will be performed and what hardware/software (if any) is required at the County to access the service.
- 4.1.1.3. The Offeror is cautioned that it is the Offeror's sole responsibility to submit information related to the evaluation categories, and that the County is under no obligation to solicit such information if it is not included with the proposal. The Offeror's failure to submit such information may cause an adverse impact on the evaluation of the proposal. Any Offeror whose responses deviate from the outlined specifications may automatically be disqualified.
- 4.1.1.4. Offeror's Contacts: Offerors and their agents (including subcontractors, employees, consultants, or anyone else acting on their

behalf) must direct all of their questions or comments regarding the RFP, the evaluation, etc. to the buyer of record indicated on the first page of this RFP. Offerors and their agents may not contact any County employee other than the buyer of record regarding any of these matters during the solicitation and evaluation process. Inappropriate contacts are grounds for suspension and/or exclusion from specific procurements. Offerors and their agents who have questions regarding this matter should contact the buyer of record.

- **4.1.2. Competitive Negotiation of Proposals:** The Offeror is advised that under the provisions of this Request for Proposal, the County reserves the right to conduct negotiations of the proposals received or to award a contract without negotiations. If such negotiations are conducted, the following conditions shall apply:
 - 4.1.2.1. Negotiations may be conducted in person, in writing, or by telephone.
 - 4.1.2.2. Negotiations will only be conducted with potentially acceptable proposals. The County reserves the right to limit negotiations to those proposals, which received the highest rankings during the initial evaluation phase.
 - 4.1.2.3. Terms, conditions, prices, methodology, or other features of the Offeror's proposal may be subject to negotiation and subsequent revision. As part of the negotiations, the Offeror may be required to submit supporting financial, pricing and other data in order to allow a detailed evaluation of the feasibility, reasonableness, and acceptability of the proposal.
 - 4.1.2.4. The mandatory requirements of the Request for Proposal shall not be negotiable and shall remain unchanged unless the County determines that a change in such requirements is in the best interest of the entities.

4.1.3. Evaluation and Award Process:

- 4.1.3.1. After determining a responsible Offeror and a responsive proposal through the determination that the proposal satisfies the mandatory requirements stated in the Request for Proposal, the evaluator(s) shall use both objective analysis and subjective judgment in conducting a comparative assessment of the proposal in accordance with the evaluation criteria stated below:
 - a. Method of Performance
 - b. Experience/Expertise
 - c. Cost

4.1.3.2. After an initial evaluation process, a question and answer interview may be conducted with the Offeror, if deemed necessary by the County. In addition, the Offeror may be asked to make an oral presentation of their proposal to the evaluation team at a designated Boone County location. Attendance cost shall be at the Offeror's expense. All arrangements and scheduling will be coordinated by the County.

4.1.4. Evaluation:

- 4.1.4.1. Experience and reliability of the Offeror's organization are considered subjectively in the evaluation process. Therefore, the Offeror is advised to submit any information, which documents successful and reliable experience in past performances, especially those performances related to the requirements of this RFP.
- 4.1.4.2. The Offeror should provide the following information related to previous and current services/contracts performed by the Offeror's organization and any proposed subcontractors which are similar to the requirements of this RFP (This information may be shown on the form attached as Attachment B to this RFP or in a similar manner):
 - a. Name, address, and telephone number of client/contracting agency and a representative of that client/agency who may be contacted for verification of all information submitted:
 - b. Dates and locations of the service/contract; and
 - c. A brief, written description of the specific prior services performed and requirements thereof.
- 4.1.4.3. The Offeror should submit a copy of all licenses, certifications, accreditation, and/or permits, which may be required by state, federal, and/or local law, statute, or regulation in the course of conduct of the Offeror's business. - 4.1.4.5. Where the words "shall" or "must" are used, they signify a required minimum function of system capacity that will heavily impact the Bidder's final response rating.

- 4.1.4.6. Where the words "should", "may" or "desired" are used, they signify that the feature or capacity is desirable but not mandatory; therefore, the specifications in question will possess minimal impact on the Bidder's final response rating.
- 4.1.4.7. The method by which the proposed method of performance is written will be left to the discretion of the Offeror. However, the Offeror should address each specific paragraph and subparagraph of the Specifications by paragraph and page number as an item for discussion.
