**Scope of Project Construction:** To clean and install a steel reinforced paved invert in (3) three 84" x 70' culverts located on Lake of the Woods Road. Work will consist of welding, steel reinforcement, concrete placement, toe-wall installation with steel reinforcement and a Rip-Rap bed at/across the in-flow of all (3) three culverts.
