**ADDENDUM #2 - Issued February 9, 2009**

This addendum is issued in accordance with the Introduction and General Conditions of Bidding in the Request for Bid and is hereby incorporated into and made a part of the Request for Bid Documents. Bidders are reminded that receipt of this addendum should be acknowledged and submitted with Bidder's *Response Form*.


Specifications for the above noted Request for Bid and the work covered thereby are herein modified as follows, and except as set forth herein, otherwise remain unchanged and in full force and effect:

**I. The County received the following question and has provided the following response:**

**Question 1:** Of the sign systems that are mentioned in the bid document, the APCO Accord system is the only system that allows you to buy individual sign components and assemble the sign yourself. Since we have the capability to produce the Photopolymer Plaques and the vinyl copy for the inserts, we were planning on assembling the signs from our components and the APCO components. In the APCO system, the endcaps/siderails are permanently attached to the wall and the plaque components and the inserts snap into the endcaps/siderails. To change the inserts, you must use a tool that comes with the system, and pop the inserts out. In the bid document page 4-10431 section 10, it states that the endcaps should be removable and the inserts should slide out from the end without the need for additional tools, or the inserts should be held in place magnetically. Does this preclude us from using the APCO system on this job?

**Response:** APCO signs are acceptable to use. It is acceptable to use tools to have to pop off the end caps to slide the inserts out. Not all of the inserts have to be held in magnetically. For the modular signs only, the 1x18 inserts will be inserted into the magnetic insert rail (sign types M & N). The 1x18 inserts (on Sign types M & N) need to be easily removed as they will be changed out daily. Even if they are not held in place by a magnet, they need to be easily accessed. It is the County's wish to not have to pop off the end cap with a tool every time the 1x18 inserts on the signs M & N need to be changed. Regarding every other insert that isn't a 1x18, it's ok to have to use a tool to remove the insert.
