Scope of Project Construction: Work consists of Total Surface Hydro Demolition and sealing of 3 Bridge Decks as identified. Work will consist of total surface hydro demolition of bridge decks as per manufacturer's specifications, patching of bridge decks with designated multi-purpose, high-strength, non-shrink, non-metallic, latex modified concrete as per manufacturer's specifications, and applying a penetrating sealant with sand application as per manufacturer's specifications.

Sealed bids will be accepted until 1:15 p.m. on August 13th at the Boone County Purchasing Office, 601 E. Walnut, 2nd Floor, Columbia, Missouri, 65201. Bids received after the above specified time for acceptance will be returned to the sender unopened.

Bids will be publicly opened after 1:30 p.m. on August 13th in the Boone County Commission Chambers, Boone County Government Center, 801 E. Walnut, Columbia, MO 65201.

Not less than the prevailing hourly rate of wages, as found by the Department of Labor and Industrial Relations of Missouri, shall be paid to all workers performing work under this Contract. The Contractor's bond shall include such provisions as will guarantee the faithful performance of the prevailing hourly wage rate as provided by the Contract.
