**Bid Closing Date/Time: September 16, 2014, 2:00 pm, CT**

Addendum #1 is issued in accordance with this Request for Bid and is hereby incorporated into and made a part of the Request for Bid documents. Bidders are reminded that receipt of this addendum should be acknowledged and submitted by the Bid Closing Date and Time stipulated above.

1. **Clarification:** INSTRUCTIONS TO BIDDERS, second page, last paragraph, Item 5- Samples of carpet tiles and vinyl composite tile, with color charts. *Clarification-* samples of carpet tiles and vinyl composite tile shall be provided with bid response if bidder elects to quote products other than those listed in the bid specifications.
2. The following areas were noted to have vinyl composite tile currently in place and will need to be removed in order to replace with new flooring as per the bid specifications:  
Building A- Room A056 currently has VCT; closets noted on floor layout that need flooring replacement currently have VCT; Room A061 currently has VCT; Building B- Room B101 has VCT; B102 is suspected to have VCT under current carpeting.
3. The following areas were noted to have ceramic tile, which will remain and are not part of the floor covering project: A024 (some ceramic tile on floor), A031 (ceramic base), A051 and A052 (ceramic base), A050 (ceramic base).
4. For those areas on the flooring layout diagram noted to receive color stain, a **solid** color stain is desired. The color choice will be selected from successful bidder.
5. **Amend:** Section 2, Primary Specifications, SURFACE PREPARATION: The following statement (Note: only an epoxy product that remains clear when applied to surfaces can be used on areas that will not have carpet) shall be **amended** to read:  
"Note: only a moisture vapor barrier sealer product that remains clear when applied to surfaces can be used on areas that will not have carpet."

Specifications for this Request for Bid and the work covered thereby are herein modified as stated above, and except as set forth herein, otherwise remain unchanged and in full force and effect:
