III. The County received the following questions and is providing a response below:

a. Is there a range of funding that can be written for on this proposal?

Response: Applications for funding will be accepted to fund an "Access to Services" program for children and youth nineteen years of age or less and their families. Preference will be given to programs which provide an opportunity for the BCCSB to partner with other funding sources in providing match funding for procurement of program services to maximize the ability to reach and serve children, youth and families in need in Boone County. Preference will also be given to organizations that demonstrate substantive and ongoing collaboration with other organizations.

b. Does the funding allow for any (staff) time on these proposals? Do you have a list of "allowables" that can be written for on this application?

Response: Staff time to deliver proposed program may be included in the proposal. The Board <u>will consider</u> indirect expenses up to a maximum of 15% of <u>salary expense</u> only (salary expense does not include benefits). Indirect expenses include general organizational expenses such as executive management time, finance, human resources or other support services effort, liability insurance, facility rent/lease, postage, telephone, utilities, etc.
